Summarize rationale supporting determination: According to the USACE Navigability Study Lynchs River Basin Report No. 10 dated 1977, the recommended and practicable limit of “navigable waters of the U.S.” is at the confluence of the Little Lynchs River and Lynchs River (R.M. 114.3). The subject property is located downstream near R.M. 50. In addition, interstate commerce is noted along the Lynchs River to include rosin and timber transportation by pole boats and rafts in the late 1800’s.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: Jurisdictional Wetlands 1 and 2 are part of a larger wetland system that continues offsite to the north until it intersects the OHWM of the Lynchs River (TNW).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form assesses a 168.35 acre site that consists of 19.07 acres of jurisdictional freshwater wetlands and 1,339 linear feet of tributaries (perennial RPW's). The onsite wetlands are a portion of a larger wetland system that continues offsite to the north and directly abuts the Lynches River (TNW). According to the consultant and the drawings provided, the property boundary does not extend beyond the OHWM. Therefore, there is no TNW (i.e. Lynches River) located on the property. As observed on aerial photography, the two tributaries onsite appear to be oxbows from the Lynches River. Inundation in the tributaries is easily observed on aerial photos from 1994 to the present. In addition, this site consists of seven (7) non-jurisdictional ponds excavated out of uplands for an ongoing mining operation.
