- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains numerous upland excavated ditches that drain only uplands. Potential wetland areas lacked all three parameters outlined in the Corps' 1987 Wetland Delineation Manual and Regional Supplement. The potential wetland areas contain hydrophytic vegetation and hydric soils; however, they lack hydrology. Review of the data sheets in the submittal dated March 9, 2020, prepared by S&ME (agent), revealed that the site contains no hydrology or indicators of hydrology. This is consistent with the Horry Co. NWI map which depicts the potential wetland areas as PFO1/4Bd (partially ditched/drained). In addition, the site location next to the AIWW and onsite locations of upland non-jurisdictional ditches also supports the lack of onsite hydrology. The site is in close proximity to the AIWW.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
