### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site assessed on this form is a 56-acre tract consisting entirely of uplands. A site visit was conducted on April 28, 2017. No wetlands or other aquatic resources were observed during the site visit. According to soil survey information, the majority of the site is mapped as Noboco and Goldsboro soils which are non-hydric. NWI maps depict the majority of the site as uplands. Two small areas are depicted as wetlands on the NWI map. However, a data point was submitted within these 2 areas and they were observed in the field and determined to be uplands. In addition, topographic maps depict two(2) blue line features within the review area. However, during the site visit, it was determined that the features were non-jurisdictional, upland excavated ditches that were created for the purpose of draining stormwater. At the time of the site visit (April 28, 2017), a substantial rainfall event had occurred in the days prior. Flow was observed in the onsite ditches from the recent rainfall event. However, the ditches are man-made features through uplands and did not exhibit characteristics of seasonal or perennial flow.
