C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 59.52-acre parcel assessed on this form consists entirely of uplands. A desk review was performed for this review. Soil survey information depicts the site as non-hydric soils (Foxworth and Autryville). LiDAR and topographic maps also depict the site as uplands. In addition, the wetland data sheets and photographs submitted by the consultant depict a lack of hydrology and non-hydric soils throughout the site. The site also consists of one (1) non-jurisdictional ditch that was constructed entirely out of uplands for the purpose of stormwater drainage and only flows after rainfall events.
