**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 84.72 acre tract that contains 3, 147.7 linear feet of TNW (AIWW), 7.98 acres of intertidal marsh wetlands determined to be TNW due to tidal influence (Marsh TNW 1 – 7.17 ac / Marsh TNW 2 – 0.59 ac / Marsh TNW 3 – 0.22 ac), 5.85 acres of freshwater wetlands( Wetland 1 – 4.88 ac/ Wetland 2 – 0.92ac / Wetland 3 – 0.05 ac), 1.55 acres of open water (TNW) (Open Water TNW #4 1.53acres + Open Water TNW #5 0.02 acres) and 0.27 acres of Impounded WOUS (Impounded WOUS 1 – 0.12 ac / Impounded WOUS 2 – 0.15 ac).

Navigability was established based on Tidal influence. Limits of Jurisdiction for the TNW were established by MHW. Limits of jurisdiction for wetlands were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement.

Delineated wetlands were determined to be part of a contiguous wetland system that directly abuts the AIWW (TNW) both on-site and off-site. During a site visit conducted on October 15, 2014 soils within the boundaries of the delineated wetland were found to be saturated and to contain oxidized rhizospheres along living root channels. Hydrophytic vegetation was abundant and soils met multiple indicators as outlined in the "Field Indicators of Hydric Soils in the United States" guide, version 7.0, 2010. Exaggerated topographic differences observed on-site, between upland and wetland boundaries, further support the delineation.

No other potentially jurisdictional Features were observed while during the site visit.
