**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The onsite wetlands are a portion of a larger wetland system located off site. This wetland system directly abuts the upstream boundary of Pawleys Swamp, a perennial RPW. The wetland system is depicted as palustrine forested wetlands (PFO4B) on the NWI and as Lynn Haven and Hobcaw, which are hydric soils, on the soil survey. The topographic map and aerials depict a linear feature named Pawleys Swamp within this wetland system.

The tributary named Pawleys Swamp was determined to have perennial flow based on a review of the aerials, topographic map, soil survey, and NWIs. This tributary is depicted as a linear feature and a blue line on the aerials and topo, respectively. The soil survey maps this tributary and the surrounding wetlands as hydric soils and the NWIs depict this tributary as palustrine forested wetlands. Pawleys Swamp continues southwest where it flows directly into the Little Pee Dee River, a TNW.
