C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 107.6 acre tract that was determined to consist entirely of uplands. The project area was originally determined to consist entirely of uplands under JD SAC 2009-00415-4S issued on September 25, 2015 and verified during a site visit conducted on September 10, 2015 .The USGS topographic survey information located within Bishopville east quad depicts the project area as cleared uplands. The project area contains a dashed blue line feature along the south/southeast project boundary. However, based a site visit conducted on September 10, 2009 and site photos dated June 22, 2015, the portion of this feature located on-site is determined to be a combination of two non-jurisdictional linear conveyances. The NWIs depict the project area as being comprised entirely of uplands. Although, soil survey information depicts hydric soils on site, the agent's data forms and photographs, taken within areas mapped hydric, depict soils with high chroma and value. Aerial photographs depict agricultural fields with no features that would typically represent a WOUS. Due to the consistent upland depiction in all available resources to this office, the project area addressed in this form is determined to consist entirely of uplands .
