- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There are several ditches on the property that are depicted on a supplemental drawing in the administrative record. These ditches are not considered to be aquatic features as they did not display on OHW, bed and bank, or any other signs of relatively permanent flow. In addition, they were filled with living vegetation and/or a buildup of leaf litter and other organic material indicating lack of relatively permanent flow. Based on the above information, it has been determined that these ditches are non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act.**

There is a pond located on site that was confirmed during the site visit to be surrounded by non-hydric soils and excavated out of uplands, therefore it has been determined that the pond is non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act. It is labeled as “Non-jurisdictional Upland Excavated Stormwater Pond” on the survey plat associated with the project, although it is not believed to have been constructed in association with a 402 permit. A culvert connects this pond to the Jurisdictional Pond/TNW located on site which is lower in elevation and only would receive water through the culvert during storm events. During the site visit, there was no flow observed between the two ponds.

SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

The DHEC/OCRM Critical Area/TNW is part of the the tidal marshes of Clark Sound which is an estuary associated with the Atlantic Ocean. The Jurisdictional Pond/TNW is a tidal pond located at the upper limits of the DHEC/OCRM Critical Area/TNW on site.

Summarize rationale supporting conclusion that wetland is “adjacent”: The 15 square feet Jurisdictional Freshwater Wetland area on site is contiguous with the DHEC/OCRM Critical Area/TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: It has been determined that the Jurisdictional Pond/TNW and DHEC/OCRM Critical Area/TNW are subject to the ebb and flood of the tides and therefore subject to regulation under Section 10 of the Rivers and Harbors Act and Section 404 of the Clean Water Act. It has also been determinate that the Jurisdictional Freshwater Wetland is adjacent to the TNW and therefore subject to Regulation under Section 404 of the Clean Water Act.
