C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: During the 7/31/15 site visit a data point was taken in the location with the greatest probability of being wetland based on review of aerial imagery, USGS Map, NWI Map, and Soil Survey Map. The data point location did not meet the three factors required to make a wetland determination as the hydric soil requirement was not met. The remainder of the parcel consists of a mowed/maintained yard, house, pool, etc. and also did not meet the factors required to make a wetland determination. Therefore it has been determined that the project area consists of uplands and is not subject to regulation under Section 404 of the Clean Water Act.
