- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There is a ditch that originates as an erosional feature at the wetland boundary and runs along the project boundary to Ashley Phosphate Road. During the multiple site visits, the ditch did not display an OHW, bed and bank, or any other signs of relatively permanent flow. The portion of the ditch near Ashley Phosphate Road more resembles a mowed/maintained vegetated swale. Although this ditch provides a hydrologic connection to the downstream TNW, it has been determined to be non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act as it lacks signs of relatively permanent flow.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: It has been determined that the on site wetland is adjacent to an unnamed tidal creek of the Ashley River (TNW) and is therefore jurisdictional and subject to regulation under Section 404 of the Clean Water Act.
