The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: **The wetland evaluated in this significant nexus determination, which is abutting the RPW, is collectively performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. The forested wetland and stream are located in an area that is mostly developed and located near a major interstate. This wetland and stream provide breeding grounds and foraging areas for aquatic species. They also provide habitat for wildlife in the area. The wetland and stream help to trap and filter runoff and pollutants from the nearby roads and industry before they travel to the downstream TNW. The wetland and stream also perform flow maintenance by storing flood waters during times of heavy rain and during the wetter months.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The wetland evaluated in this significant nexus determination, which is abutting the RPW, is collectively performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. The forested wetland and stream are located in an area that is mostly developed and located near a major interstate. This wetland and stream provide breeding grounds and foraging areas for aquatic species. They also provide habitat for wildlife in the area. The wetland and stream help to trap and filter runoff and pollutants from the nearby roads and industry before they travel to the downstream TNW. The wetland and stream also perform flow maintenance by storing flood waters during times of heavy rain and during the wetter

months. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the downstream TNW, it has been determined there is a significant nexus between the relevant reach of the tributary and its adjacent wetlands to the downstream TNW.
