This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: SRPW 5 is performing a variety of functions that relate to the biological, chemical, and physical integrity of the downstream TNW. The seasonal tributary provides breeding grounds and foraging areas for aquatic species and habitat for wildlife in the area. The tributary is filtering runoff and pollutants from the nearby plant and roads before they travel down stream. The seasonal tributary also performs flow maintenance by storing flood water in times of heavy rain and during the wetter months. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the down stream TNW (Congaree River), it has been determined there is a significant nexuse between the relavent reach of the tributary to the downstream TNW.

- Tributaries of TNW where tributaries have continuous flow “seasonally” (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: **SRPW 5 is shown as a natural contour on the topo map. This tributary flows into Wetland D, but is impacted by a road. After the road, the tributary loses its characteristics and spreads out into the wetland. It was not observed flowing on the day of the Corps site visit, but was observed flowing during flagging by the consultant. Stream characteristics observed and available data led this office to conclude the tributary has a seasonal flow regime.**

over 1,000 feet from the nearest on-site jurisdictional water (a blue line stream with abutting wetlands). The topo map shows a signature that could possibly be a drainage feature, but this was not observed in the field by the Corps. There may have been one historically, however there have been site manipulations, such as logging, that have impacted the site. There are several logging ruts near the wetland that end in uplands and provide no connection for the wetland. Wetland A is located close to the property boundary. Any possible off-site features are located uphill from the wetland and would be flowing into the wetland. There are no signs of drainage features, shallow subsurface flow or overland flow off-site or to other waters on-site. This isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. This office has determined that this wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 329.40 acre site contains one isolated wetland (Wetland A) that is 0.59 acres. Wetland A was determined to be isolated in 2003 as a part of jurisdictional determination for a larger tract (SAC-81-2003-0566). Wetland A is over 1,000 feet from the nearest on-site jurisdictional water (a blue line stream with abutting wetlands). The topo map shows a signature that could possibly be a drainage feature, but this was not observed in the field by the Corps. There may have been one historically, however there have been site manipulations, such as logging, that have impacted the site. There are several logging ruts near the wetland that end in uplands and provide no connection for the wetland. Wetland A is located close to the

property boundary. Any possible off-site features are located uphill from the wetland and would be flowing into the wetland. There are no signs of drainage features, shallow subsurface flow or overland flow off-site or to other waters on-site. This isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. This office has determined that this wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.
