C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is a 2.28 acre site that contains approximately 1 acre of wetlands. The onsite wetlands are part of a larger wetland system that extends offsite toward the west. The wetland system continues and eventually abuts Betty Branch which is an RPW with year round flow. Betty Branch flows toward the south where it empties into the Edisto River, which is a TNW; therefore the project site is subject to regulation under Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act.
