C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 10.5 acre tract that was determined to consist entirely of uplands. The project area was originally part of a 26.85 acre tract determined to consist entirely of uplands due to the lack of any indicators of hydrology under JD SAC 2006-02034-4JT issued in October of 2006. While covered under the for mentioned JD the project area addressed in this form was partially developed. The project area now consist of a 0.5 acre upland excavated stromwater retention pond, 10 single family homes, several empty residential lots, and two roads (Lunar Lane and Moonlight Drive). The USGS topographic survey information located within LAMAR quad depicts the project area as cleared uplands. The project area does not contain any blue line features or other symbols that would typically represent a water of the United States. Although the NWIs depict wetlands and the soil survey depicts hydric soils, based on JD SAC 2006-02034-JT, a review of aerial photographs, and USGS topographic survey information the project area is determined to consist entirely of uplands..
