C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal RPW located on site is performing a variety of functions that relate to the biological, chemical, and physical integrity of the TNW. The SRPW is located in the southern portion of the site, near a road. It is located in a forested area of the site, but the majority of the site is cleared. The SRPW provides breeding grounds for aquatic species and habitat for the wildlife in the area. The SRPW also helps to filter pollutants from the nearby road and cleared areas before they travel downstream to the TNW. The SRPW stores flood water during times of heavy rain and during the wetter months before it travels downstream. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the TNW and it has been determined there is a significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION
