to collect stormwater runoff onsite. The pond was primarily open water with heavy aquatic vegetation and algae on the outer rim. The pond is non jurisdictional and not subject to Corps regulatory authority under the Clean Water Act. One non-jurisdictional ditch dug in uplands originates from the non jurisdictional pond and flows east. No water was flowing at the time of survey. The ditch did have a defined bed and bank, but lacked evidence of an Ordinary High Water Mark. The channel was mostly vegetated and it appears to flow only when the non jurisdictional pond overflows.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
