the eastern portion of the site is mapped Bladen, which is hydric. The NWIs map this entire site as wetlands (PFO4B). However, data points taken by the agent on site show that this site does not contain hydric soils or indicators of hydrology. Therefore, the site was determined to consist entirely of uplands.

An upland excavated pond was also assessed within th review area. This pond is located along the southern boundary of the parcel and was determined, based on the aerials and topographic map, to be excavated out of uplands. Therefore, this pond was determined to be non-jurisdictional.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The aerials depict this site as forested, and the topographic map depicts this site as forested uplands adjacent to an upland excavated pond/lake. The soil survey maps the majority of this site as Wahee, a non-hydric soil; however, the eastern portion of the site is mapped Bladen, which is hydric. The NWIs map this entire site as wetlands (PFO4B). However, data points taken by the agent on site show that this site does not contain hydric soils or indicators of hydrology. Therefore, the site was determined to consist entirely of uplands.
