Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are two ditches lcoated within the project review area. The ditches are freshwater and appear to have been excavated from uplands to help drain water off of the airport runways. Portions of the ditches are vegetated and open water. #### C. SIGNIFICANT NEXUS DETERMINATION
