This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 1.4 acre impoundment of W.O.U.S. This feature is depicted as a wastewater treatment pond on USGS topographic maps. Based on documentation from the agent this feature was constructed prior to the Clean Water Act of 1977, in or about 1967, and was abandoned in 1983 when the park connected to the Grand Strand Water and Sewer Authority sewage system. This feature was determined to have been excavated out of a fully functional wetland system adjacent to the Atlantic Ocean. Wetlands abutting the impoundment were saturated to the surface, obligate species such as a netted chain fern (*Woodwardia areolata*) were abundant and soils met the A12 indicator of thick dark surface. These wetlands were determined to continue off-site to the south west and to abut a series of stormwater ponds that outfall into the Atlantic Ocean through the Lakewood Family Campground Swash. Based on visual observations during a site visit conducted on July 10, 2016, portions of this feature have become overgrown with aquatic and/or hydrophytic vegetation and taken on wetland characteristics such that would meet the definition of wetlands as defined at 33 CFR 328.3(b), which states, "those areas that are inundated or saturated by surface or ground water at a frequency and duration sufficient to support and that under normal circumstances do support, a prevalence of vegetation typically adapted for life in saturated soil conditions." .
