determined to be isolated and non-jurisdictional. It is approximately 0.20 acres and sits 3-4 feet lower in the landscape than the surrounding uplands. It is bound on all sides by uplands and is adjacent to a residential subdivision and commercial development. It was a depressional feature with no outlet except through evapotranspiration. It does not have any physical hydrologic outlet and no apparent connections to waters of the U.S., including no physical, chemical, or biological connections. In addition, there was no apparent ecological interconnectivity with other water features, including any waters of the U.S., and no apparent connection to interstate or foreign commerce. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW.
