C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 55.69 acres located west of and adjacent to Harbor View Road in Myrtle Beach, SC. On site is a 749 L.F pRPW. The tributary was determined to be perennial by review of aerial photographs and during a previous site visit conducted under SAC-2007-01570-3B. It is a man-made tributary that was excavated sometime after 2007. The tributary is relatively straight and regularly maintained. It is not depicted on topographic maps. However, it is visible on recent aerial photos. Flow of the onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks had a firm sandy bottom, OHWM , clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream. Also on site are upland excavated ponds and upland excavated ditches determined to only drain uplands. USGS topographic survey information depicts a forested area that is void of any wetland symbols. The project area is comprised of the hydric soil Bladen and the non-hydric soil Undorthents and udipsamments. NWI maps map the project area as uplands (U17, U42P) and ditched/drained wetlands (PFO1/4Bd)
