C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was conducted on August 7, 2017. All of the necessary resources were used to make the correct determination for the site. The aerial, topographic, soils survey, and national wetlands inventory maps were used to complete the determination. The topographic map does depict a linear feature in the northwest portion of the site. After review it was determined that the linear feature was a non-jurisdictional upland excavated drainage ditch. Aerial photography located in the file from years 2005, 2006, and 2011 depict the site as being used for active agricultural practices. The linear feature onsite was excavated in uplands and is used to drain uplands. An additional photograph shows the non-jurisdictional upland excavated drainage ditches connectivity offsite. The land adjacent to the site is a developed residential neighborhood. The soil survey shows the majority of the site being mapped as Noboco loamy sand soil which is non-hydric and a portion of the site is mapped with hydric Coxville sandy loam soil. The National Wetlands Inventory shows the entire site as being mapped (U21) Uplands. After reviewing all of the information listed above, it was determined that the site in question consists entirely of uplands and that no wetlands and / or other waters of the United States are located onsite. .
