Horry County LiDAR, and a previous delineation associated with SAC 1997-28663 these ponds were determined to have been excavated wholly out of uplands and are therefore determined to be non-jurisdictional.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: **Based on a site visit conducted on July 26, 2017, wetland 1 overflows through two PVC pipes and drains into a non-jurisdictional storm water pond located near the south east corner of the property. The pond drains into a storm water catch basin and leaves the site beneath the adjacent parking lot and Horseshoe road. This observation is confirmed by a depiction of the storm water plan for the site. Based on aerial photographs, the stormwater plan and LiDAR, the water appears to travel south along Horseshoe road and then make a sharp right turn along U.S. Highway 17 and the merge with a pRPW (SAC-2015-00433) which then flows though several ponds/impoundments before it eventually discharges into the Atlantic Intracoastal Waterway (AIWW) approximately half a mile down gradient. Wetland 1 was determined to be adjacent non-abutting the AIWW, a TNW..**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 0.20 acre wetland that was determined to be adjacent/non-abutting the AIWW, a TNW. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Based on a site visit conducted on July 26, 2017, wetland 1 overflows through two PVC pipes and drains into a non-jurisdictional storm water pond located near the south east corner of the property. The pond drains into a storm water catch basin and leaves the site beneath the adjacent parking lot and Horseshoe road. This observation is confirmed by a depiction of the storm water plan for the site. Based on aerial photographs, the stormwater plan and LiDAR, the water appears to travel south along Horseshoe road and then make a sharp right turn along U.S. Highway 17 and the merge with a pRPW (SAC-2015-00433) which then flows though several ponds/impoundments before it eventually discharges into the Atlantic Intracoastal Waterway (AIWW) approximately half a mile down gradient. Wetland 1 was determined to be adjacent non-abutting the AIWW, a TNW.

The project area also contains three upland excavated ponds. Based on a review of aerial photography, Horry County LiDAR, and a previous delineation associated with SAC 1997-28663 these ponds were determined to have been excavated wholly out of uplands and are therefore are determined to be non-jurisdictional.

The project area also contains a 0.35 acre jurisdictional wetland that is addressed on Basis Form 2 of 2 of this determination.

Other information (please specify): **Horry County 2009 LiDAR depicts depressional features at the location of wetland 2 and the ponds located in vicinity. Based on a review of the LiDAR there are no natural or man made barriers between Wetland 2 and the offsite pond. A low lying drainage area can be seen that would serve as a path for water to discharge from the pond and flow through an observed culvert beneath River Hills Drive. In addition a LiDAR depicts a drainage feature that appears to be an out fall from the ponds under Eagles nest Road and into Cedar Creek.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 0.35 acre wetland that was determined to be adjacent/non-abutting Cedar Creek, a TNW. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Based on a site visit conducted on July 26, 2017 and a review of Horry County LiDAR, wetland 2 directly abuts a large pond located off-site to the south. This feature drains beneath river hills drive and through several golf course ponds before discharging into Cedar Creek, a TNW, approximately a half mile down gradient. Cedar Creek is subject to the Ebb and Flow of the tide. This determination was documented in Approved JD SAC 2003-35137 issued on 1/14/14

The project area also contains a 0.20 acre jurisdictional wetland and three upland excavated ponds that are addressed on Basis Form 2 of 2 of this determination.
