Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project area is mapped as forested wetlands (PFO1/4B). However, these areas lacked the three parameters which define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual. The parameter specifically not present was the hydrology prarameter. Data forms submitted by the Brigman Company revealed the hydrology had been altered due to the drianinage ditch adjacent to the property. Hydrological indicators were not observed. Also present on site is a ditch that was determined to drian only uplands.

### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 0.43 acre site located off of Ridgewood Drive, Conway, SC. The site is comprised of former agricultural fields. USGS topographic survey information depicts a forested area that is void of any blue line and wetland symbols. Soil survey information depicts the hydric soil Yongesand the partially hydric soil Eulonia. NWI map depict forested wetlands, however data forms submitted by the agent show that the hydrology parameter, as outlined in the Corps' 1987 Wetland Delineation Manual, was not met. The site hydrology has been altered due to lot and road layouts and associated stormwater improvements. Based on a combination of the above listed resources and previous determinations the project area was determined to be void of aquatic resources.
