C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

NWI maps the majority of the project boundary as uplands and the remainder of the site as forested wetlands. Aerial photos show a majority of the upland areas as cropland. USGS topographic survey information depicts a partially cleared forested area with a blue line present in the eastern portion of the project area, a site visit revealed that these features were not present. The project area is comprised of partially hydric (Yemasee and Yauhannah) and hydric soils (Yeamsee). NWI maps the majority of the project boundary as uplands and the remainder of the site as forested wetlands. Aerial photos show a majority of the upland areas as cropland. Also present on site was an upland excavated non-jurisdictional ditch determined to drain only uplands. .
