of the site. The wetland is located in a depressional area of the site with a berm on the eastern side of the wetland. There are no signs of flow or drainage patterns to any other waters on-site or off-site. The isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetlands and waters of the U.S. This office has determined that the wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Summarize overall biological, chemical and physical functions being performed: **The wetlands evaluated in this SND are performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. WOUS 1 Wetland is adjacent but not directly abutting WOUS 2 Non-Wetlands Water, a seasonal RPW due to a discrete wetland hydrologic connection as seen during the Corps site visit. WOUS 3 Wetland is directly abutting WOUS 2 Non-Wetlands Water, a seasonal RPW. A variety of biological functions are being performed by the wetlands. The wetlands provide possible breeding grounds for aquatic species as well as habitat for wildlife in the area. The chemical functions include nutrient and waste filtration for the surrounding urban and agricultural areas. The physical functions of the wetlands include flow maintenance by retaining runoff and storm water during times of heavy rain and during the wetter months.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Functions of the tributary and wetlands that impact the chemical integrity of the TNW downstream include the filtering of excess nutrients contributed by runoff from the surrounding uplands due to residential areas, which reduces nitrogen and phosphorus loading downstream. A variety of biological functions are being performed by the seasonal RPW and adjacent wetlands, which include providing breeding grounds and shelter for aquatic wildlife and foraging areas for water dependent species and other wildlife. These tributary provides diversity through vegetation changes, and where the aquatic system adjoins the adjacent uplands.

Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable water of the Saluda River, it has been determined that there is a significant nexus between the relevant reach of the tributary and adjacent wetlands to the downstream TNW.
