C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review is comprised of 6.87 acres total and includes 0.02 acre of isolated wetlands.

Wetland hydrology was present within the boundaries of the isolated wetland. Georgetown County Soil Survey / pg 33 / depicts the following symbology, depicts the following non hydric soils: Centenary & Lakeland soils and the following hydric soils: Leon. Georgetown county NWI data depict the site as uplands and palustrine wetlands. The isolated wetland is approximately 3200 linear feet from Clubhouse Creek. The isolated wetland has no connections to other Waters of the US (WOUS) after reviewing available office resources.
