C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This form addresses a 65.12 acres site that contains a single perennial RPW (tributary) located on an abandoned golf course. The onsite PRPW was determined to flow at least 90% of the year, under normal climatic conditions, due to the clear signature depicted on aerial imagery, and offsite observations of this tributary during other site visits. Additionally, Horry County LiDAR aerial imagery confirms the presence of a free flowing tributary.

Additionally, located onsite are six (6) upland excavated non-jurisdictional ponds that are encompassed by uplands and are not connected to other WOUS.
