- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Two ditches were observed while on-site. Both ditches were determined to be non-jurisdictional. The larger ditch observed along the eastern property boundary was previously determined to be a non-wetland water in the PJD dated April 2, 2015 (SAC-2012-00362). However, after further observation, the ditch exhibited a discontinuous OHWM and did not exhibit characteristics of at least seasonal flow (i.e. sediment sorting, wrack lines, scouring, etc.) This feature is a man-made drainage ditch created for the purposes of stormwater conveyance. The remaining smaller ditch was located near the center of the property and exhibited no characteristics of flow. It was determined that this feature was also for the purpose of conveying stormwater and, therefore, non-jurisdictional.** There were four other ditches identified on-site that were not observed in the field. However, after researching aerial photos, topo maps, and lidar information, it was determined that these ditches were also man-made drainage ditches excavated entirely out of uplands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A site visit was conducted on July 9, 2019, in response to a pre-application meeting request that was submitted by the consultant on May 23, 2019, for the purpose of reviewing the area (soils, vegetation, and hydrology) prior to submitting a JD request. There is currently a Preliminary JD (PJD) (SAC-2012-00362) which was issued April 2, 2015, for the entire Goretown Mine site that includes the tract referenced in this request. The PJD identified waters of the US on the site. However, after further field observations, research, and information submitted by the consultant, the Corps has determined that the 48.5 acre portion subject to this review consists entirely of uplands. Several soil samples were taken throughout the site. Greater than 30% uncoated sand grains within the upper 6 inches of each sample were observed (see file photos). In addition, no indicators of hydrology were observed throughout the site and Northern Bracken Fern (*Pteridium aquilinum*) (FACU) was present in abundance throughout the entire site.

In addition to the areas determined to be non-wetlands, two ditches were also observed. Both ditches were determined to be non-jurisdictional. The larger ditch observed along the eastern property boundary was previously determined to be a non-wetland water in the PJD referenced above. However, after further observation, the ditch exhibited a discontinuous OHWM and did not exhibit characteristics of at least seasonal flow (i.e. sediment sorting, wrack lines, scouring, etc.) This feature is a man-made drainage ditch created for the purposes of stormwater conveyance. The smaller ditch was located near the center of the property and exhibited no characteristics of flow. It was determined that that this feature was also for the purpose of conveying stormwater and, therefore, non-jurisdictional. There were four other ditches identified on-site that were not observed in the field. However, after researching aerial photos, topo maps, and lidar information, it was determined that these ditches were also man-made drainage ditches excavated entirely out of uplands.

This determination (SAC-2019-00857) will supersede the determination issued on April 2, 2015 (SAC-2012-00362) for this 48.5 acre parcel.
