**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 167.94 acre site that was determined to consist entirely of uplands. The project area currently consist of a golf course. The site contains 8,196 linear feet of upland excavated non-jurisdictional ditches and a 7.66 acre upland excavated non-jurisdictional pond/lake. Based on a review of historic aerial photographs, USGS topo graphic survey information and NWIs these features were determined to have been excavated out of uplands and to drain only uplands and are therefore determined to be non-jurisdictional. USGS topographic information within Nixonville quad depicts the project area as vegetated uplands with varying topographic relief. A non-sinuuous solid blue line feature is depicted bisecting the site. Based on a review aerial photographs this feature does not currently exist within the project boundary. Historic aerials reveal that the feature was likely an upland excavated drainage ditch associated with historic silviculture activities. NWIs depict the site as uplands that contain a portion of what is described as an excavated permanently flooded lacustrine feature with an unconsolidated bottom.**
