- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Data sheets provided by the consultant indicate that no wetland characteristics are present within the review area. Although lidar data suggests that a depressional area may exist in the southeastern corner of the review area, aerial imagery and Google Street View photographs taken when vegetation was partially cleared do not show any indication of aquatic features in this area. Therefore, the review area is comprised entirely of dry land and is not subject to Section 404 of the Clean Water Act or Sections 9 and 10 of the Rivers and Harbors Act.
