north and west sides while an apartment complex is located on the south side. On the east side, a buried sewer line runs along the review area boundary which creates an elevated berm between the review area and an artificial lake associated with the neighboring residential area. The wetlands appear to only collect stormwater from the surrounding uplands and no connection to an offsite jurisdictional water was observed. Therefore, this feature is a non-adjacent wetland under the Navigable Waters Protection Rule and is not subject to regulation under Section 404 of the Clean Water Act or Sections 9 and 10 of the Rivers and Harbors Act.
