Explain: **Two (2) non-jurisdictional ditches were identified throughout the project area. These features did not exhibit hydrologic indicators such as: ordinary high water mark, bed, bank, substrate and sediment sorting. There is an approximate 0.32 acre open water pond on the eastern portion of the project area and an approximate 0.19 acre open water pond on the western portion of the project area. The ponds were excavated from uplands and serve for recreational purposes. For these reasons, these features were determined to be non-jurisdictional.**

Summarize rationale supporting determination: TNW 1 is a tidal wetland (marsh) of the Wadmalaw River and subject to the ebb and flow of the tide. Best available imagery depicts Other Jurisdictional WOTUS 2 and Other Jurisdictional WOTUS 3 as a tidal tributary and marsh directly flowing into the Wadmalaw River in a 1957 aerial. The tidal tributary was impounded sometime after 1957. In accordance with 33 CFR 329.9(a) “A waterbody which was navigable in its natural or improved state, or which was susceptible of reasonable improvement (as discussed in §329.8(b) of this part) retains its character as “navigable in law” even though it is not presently used for commerce, or is presently incapable of such use because of changed conditions or the presence of obstructions. Nor does absence of use because of changed economic conditions affect the legal character of the waterbody. Once having attained the character of “navigable in law,” the Federal authority remains in existence, and cannot be abandoned by administrative officers or court action. Nor is mere inattention or ambiguous action by Congress an abandonment of Federal control. However, express statutory declarations by Congress that described portions of a waterbody are non-navigable, or have been abandoned, are binding upon the Department of the Army. Each statute must be carefully examined, since Congress often reserves the power to amend the Act, or assigns special duties of supervision and control to the Secretary of the Army or Chief of Engineers.” The Wadmalaw River is a free flowing tidal river subject to the ebb and flow of the tide. Therefore TNW 1, Other Jurisdictional WOTUS 2, and Other Jurisdictional WOTUS 3 River are considered to be TNWs..

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form documents the jurisdictional status of three jurisdictional features. TNW 1 is a tidal wetland (marsh) of the Wadmalaw River and subject to the ebb and flow of the tide. Best available imagery depicts Other Jurisdictional WOTUS 2 and Other Jurisdictional WOTUS 3 as a tidal tributary and marsh directly flowing into the Wadmalaw River in a 1957 aerial. The tidal tributary was impounded sometime after 1957. In accordance with 33 CFR 329.9(a) “A waterbody which was navigable in its natural or improved state, or which was susceptible of reasonable improvement (as discussed in §329.8(b) of this part) retains its character as “navigable in law” even though it is not presently used for commerce, or is presently incapable of such use because of changed conditions or the presence of obstructions. Nor does absence of use because of changed economic conditions affect the legal character of the waterbody. Once having attained the character of “navigable in law,” the Federal authority remains in existence, and cannot be abandoned by administrative officers or court action. Nor is mere inattention or ambiguous action by Congress an abandonment of Federal control. However, express statutory declarations by Congress that described portions of a waterbody are non-navigable, or have been abandoned, are binding upon the Department of the Army. Each statute must be carefully examined, since Congress often reserves the power to amend the Act, or assigns special duties of supervision and control to the Secretary of the Army or Chief of Engineers.” The Wadmalaw River is a free flowing tidal river subject to the ebb and flow of the tide. Therefore TNW 1, Other Jurisdictional WOTUS 2, and Other Jurisdictional WOTUS 3 River are considered to be TNWs.

Two (2) non-jurisdictional ditches were identified throughout the project area. These features did not exhibit hydrologic indicators such as: ordinary high water mark, bed, bank, substrate and sediment sorting. There is an approximate 0.32-acre open water pond on the eastern portion of the project area and an approximate 0.19 acre open water pond on the western portion of the project area. The ponds were excavated from uplands and serve for recreational purposes. For these reasons, these features were determined to be non-jurisdictional.
