jurisdictional. The wetlands are approximately 0.976 acres and 0.122 acres in size, respectively. They consist of concave, depressional gum ponds and are surrounded by upland areas, including U.S. Hwy 17. They are separated from a neighboring upland excavated, non-jurisdictional pond by an approximately 4' wide earthen berm. They receive runoff from these areas, but their only outlet is through evapotranspiration. They do not have either a surface or apparent subsurface hydrological connections and no apparent ecological interconnectivity with other water features, including any waters of the US and no apparent connections to interstate or foreign commerce. The features do extend off property, but as referenced above, do not have any apparent subsurface hydrological connections and/or ecological interconnectivity. Therefore, these wetlands were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

C. SIGNIFICANT NEXUS DETERMINATION
