

## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The tributary named Long Branch was determined to flow year-round based on a review of the aerials, topographic map, soil survey, and NWIs. The aerials and topographic map depict this tributary as a shaded linear feature and a solid blue line, respectively. The soil survey maps this tributary and the abutting wetland system as Rutledge, a hydric soil. The NWIs map this tributary and the abutting wetlands as palustrine forested wetlands (PFO1C). Long Branch continues flowing southeast where it enters Mush Swamp, a PRPW. Mush Swamp flows into Green Swamp, a pRPW, which flows into the Pocotaligo River, a pRPW. The Pocotaligo River flows southeast into the Black River, a TNW. Jurisdictional Wetlands A and B are portions of the same wetland system that directly abuts the onsite perennial RPW named Long Branch. The soil survey maps these two wetlands as Rutledge, a hydric soil, and Lynchburg, a partially hydric soil. The NWIs map these two wetlands as palustrine forested (PFO1C). These wetlands are depicted on the topographic map as forested wetlands that surround the blue line named Long Branch. .
