Explain: **A potentially jurisdictional wetland located within the project area and continues offsite was determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain a site visit conducted on October 18, 2017 revealed that the wetland onsite is completely encompassed by soils that do not meet the hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface of subsurface hydrologic connection is inhibited**

Also present on site are upland excavated non-jurisdictional ditches determined to be non-jurisdictional under approved JD SAC-2015-0064-3B letter dated August 6, 2015..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain a site visit conducted on October 18, 2017 revealed that the wetland onsite is completely encompassed by soils that do not meet the hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface or subsurface hydrologic connection is inhibited. Also on site are upland excavated ditches determined to drain only uplands. USGS topographic survey information depicts a forested area void of blue lines or wetland symbols. The project area is comprised of the hydric soils Chipley fine sand and Leon Sand. NWI maps depict the project area as entirely uplands .
