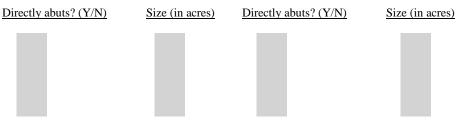

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. **B.** ADDITIONAL COMMENTS TO SUPPORT JD: This form assesses a 19 acre site known as Ruiz Foods Tract 1. After researching the best available information (i.e. aerial photographs, topographic maps, soil survey information, NWI maps, and the data sheets and pictures submitted by the agent), it was determined that the entire site consists of uplands. The NWI maps depict the site as uplands (U12). The soil survey information depicts the site as Wagram and Norfolk soil types, both partially hydric with only 2% of soil component considered hydric. The topo map does not depict any wetland areas or tributaries (i.e. blue lines) within the project boundary. A ditch was assessed on the site by the agent. After reviewing the information above, it was determined that the ditch was excavated entirely out of uplands and drains only uplands and is non-jurisdictional.
