- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There are two wetlands, Wetlands 1 and 2, located within the project review area that were determined to be isolated and non-jurisdictional. Both wetlands are surrounded by uplands, are depressional and positioned lower in the landscape than the adjacent uplands. There were no ditches, swales, or other linear features coming out of the wetlands. The boundary of Wetland 2 appears to continue onto the adjacent property by approximately 25 feet where it then ends. Not ditches, swales or other features were observed to be coming out of the offsite portion of Wetland 2. Based on review of aerial and topographic maps, no tributaries wetlands, or other waters are present in the vicinity of the onsite wetlands. No visible surface hydrologic connections between the wetlands and waters of the U.S. appear to be present. In addition, there are no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. The wetlands also have no apparent ecological interconnection to waters of the U.S. For these reasons, Wetland 1 and 2 were determined to be isolated and non-jurisdictional and therefore not regulated by Section 404 of the CWA.**

There is also one linear conveyance located within the project review that was determined to be non-jurisdictional. The linear feature is a shallow ditch located in uplands. The ditch was dry at the time of the visit and displayed no OHW mark nor evidence of relatively permanent flow. The linear conveyance begins near the property boundary and ends before reaching Wetland 2. For these reason, this linear feature was determined to be non-jurisdictional and not regulated by Section 404 of the CWA.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD:** Two wetlands are located within the project review area and were determined to be isolated non-jurisdictional and therefore not regulated by section 404 of the CWA. A non-jurisdictional linear conveyance is also located within the project review area and was also determined to be non-jurisdictional and not regulated by Section 404 of the CWA.
