C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 Wetland Delineation Manual.
The wetland demonstrated the appropriate hydrology (saturation near the surface was observed during the field audit), hydrophytic vegetation, and hydric soils to classify it as a wetland. The wetland in the review area is part of a large wetland system that continue offsite and are bisected by the OHMW of an unnamed perennial RPW prior to discharging into Mill Swamp, another perennial RPW. The RPW is represented by a blue line on the USGS topographic map which is the symbol for a perennial flow and has a clearly defined channel with bed and banks, evident from aerial photography. A review of USGS topographic maps, Horry County Soil Survey publications, and aerial photography concur with the conclusion that the tributary is perennial, flowing at least 95% of the year. The offsite unnamed perennial RPW discharges directly into Mill Swamp Mill Swamp which discharges directly into the Waccamaw River, a named TNW.

No ponds or ditches were located onsite.

This site was accessed on one basis form.
