perimeter of Wetland 1 (northern property boundary) was observed in the field and determined to be completely surrounded by non-hydric soil. The entire perimeter of Wetland 2 (southern property boundary) was not observed in the field because a portion of the wetland was offsite and access was restricted. However, after reviewing aerial photography, topo maps, NWI maps, soil survey information and a current JD (SAC# 2007-02231-3H Letter dated 3/18/2013) on the adjacent property to the south, it was determined that Wetland 2 is also surrounded by non-hydric soil and is non-jurisdictional. The wetland delineation map of the adjacent JD is in the file for reference. Therefore, no surface or shallow subsurface connection, from Wetlands 1 & 2, to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. Topographic maps do not depict any wetland symbols or tributaries (i.e. blue lines) on the property or within close proximity to the subject wetland. No ditches or swales were observed in the field. The onsite wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

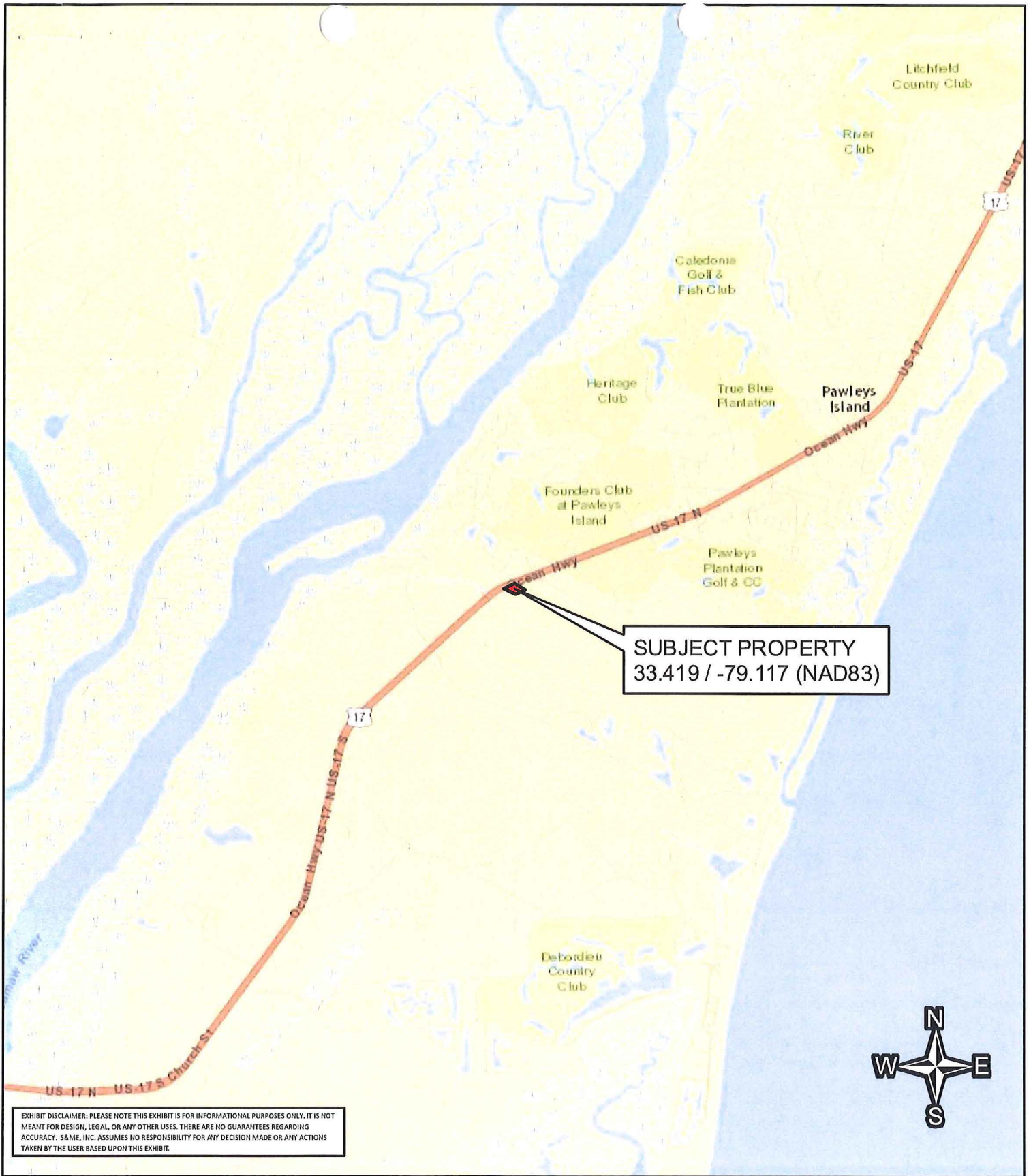

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Two wetlands were assessed in the field and determined to be isolated (non-jurisdictional). The entire perimeter of Wetland 1 (northern property boundary) was observed in the field and determined to be completely surrounded by non-hydric soil. The entire perimeter of Wetland 2 (southern property boundary) was not observed in the field because a portion of the wetland was offsite and access was restricted. However, after reviewing aerial photography, topo maps, NWI maps, soil survey information and a current JD (SAC# 2007-02231-3H Letter dated 3/18/2013) on the adjacent property to the south, it was determined that Wetland 2 is also surrounded by non-hydric soil and is non-jurisdictional. The wetland delineation map of the adjacent JD is in the file for reference. Therefore, no surface or shallow subsurface connection, from Wetlands 1 & 2, to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. Topographic maps do not depict any wetland symbols or tributaries (i.e. blue lines) on the property or within close proximity to the subject wetland. No ditches or swales were observed in the field. The onsite wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.

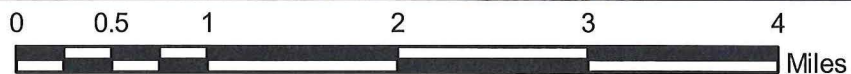
