- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A potentially jurisdictional wetland located within the project area was determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, water on site appears to drain into the wetland. A site visit conducted on October 21, 2015 revealed that the wetland onsite is bordered to the north south and east by uplands that do not meet the hydric soils criteria. The wetland appears to continue off-site to the west, however all of the available desk top resources this office, to include: NWIs, USGS topographic maps, Darlington County LiDAR with Hydrolines, Soil survey information, and aerial photographs, reveal that the offsite wetland is bordered off-site to the north west and south by uplands and is not adjacent to or intersected by any drainage features that could possibly provide a connection to a downstream TNW. Offsite uplands with no drainage features were observed along Turnpike Road, Bonnie Drive and Monique Road to the north, west and south of the suspected wetland area.

One upland excavated pond is located within the project area and determined to be non-jurisdictional. This pond was depicted on the USGS topographic surevy maps as draining into High Hill Creek, to the south of the project area, however a site visit conducted on October 21, 2015 revealed that the pond was excavated out of uplands and that there are no culverts or other structures located in or around the pond. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 2.6 acre tract that contains approximately 1 acre of wetland that in itself meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, but was determined to have no discernable or traceable outfall connections to other Waters of the US based on all of the available desk top resources this office, to include: NWIs, USGS topographic maps, Darlington County LiDAR with Hydrolines, Soil survey information, and aerial photographs. A site visit conducted on October 21, 2015 revealed that the wetland onsite is bordered to the north south and east by uplands that do not meet the hydric soils criteria. The wetland appears to continue off-site to the west, however all of the available desk top resources this office reveal that the offsite wetland is bordered to the north west and south by uplands and is not adjacent to or intersected by any drainage features that could possibly provide a connection to a downstream TNW. Offsite uplands with no drainage features were observed along Turnpike Road, Bonnie Drive and Monique Road to the north, west and south of the suspected wetland area.

One upland excavated pond is located within the project area and determined to be non-jurisdictional. This pond was depicted on the USGS topographic survey maps as draining into High Hill Creek, to the south of the project area, however a site visit conducted on October 21, 2015 revealed that the pond was excavated out of uplands and that there are no culverts or other structures located in or around the pond.

Although a 1000 year rain event occurred 2 weeks prior to the site visit the area had previously been under drought conditions. According to NRCS WETS data the large amount of rainfall brought the area back to normal conditions. Due to the fact that the water from the surrounding uplands drains into the wetland and there is no outlet the wetland was overflowing. Large amounts of clay fill were preventing the excess water from seeping into the soils below, therefore hydrology at the surface within the uplands was greatly exaggerated. Although Hydrology was present throughout the site, soil within the uplands contained high chroma and value, and therefore did not meet a hydric soil indicator.


