C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

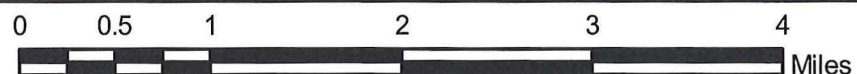
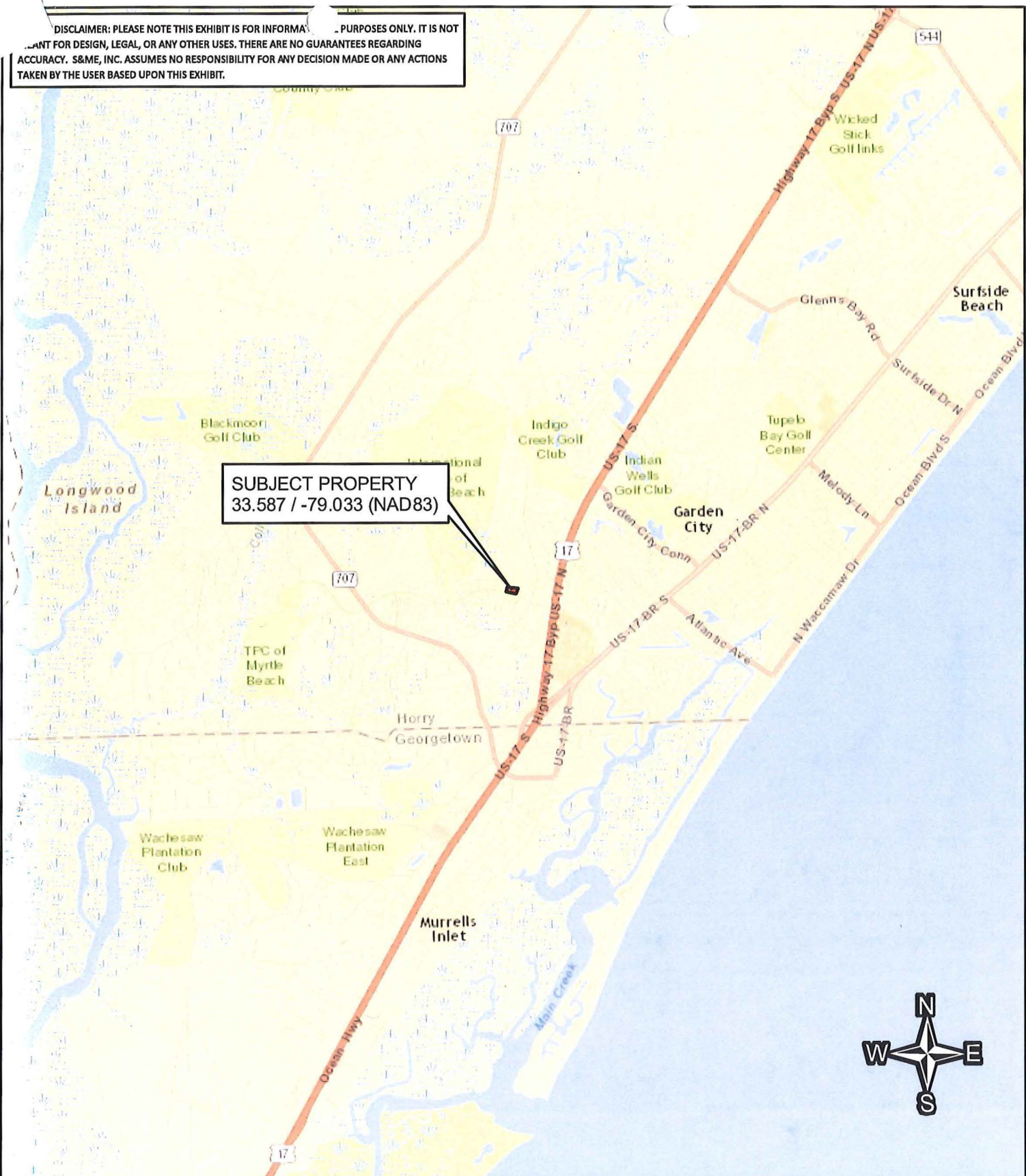

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form assesses a 2.114 acre site consisting entirely of uplands. No site visit was conducted for this determination. However, after researching the best available information (i.e. soil survey information, NWI maps, aerial photos) and the consultants supplemental information, the Corps has determined that the subject property is void of wetlands or other waters of the U.S. According to soil survey information the review area is mapped as Yauhannah (non-hydric) and Yemassee (non-hydric). A portion of the property is mapped as uplands on NWI maps. There is another portion of the property that is mapped as palustrine forested wetlands. However, according to the consultant's data sheets and photos in the file, this area consists of non-hydric soils and no evidence of hydrology was present.
