C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). 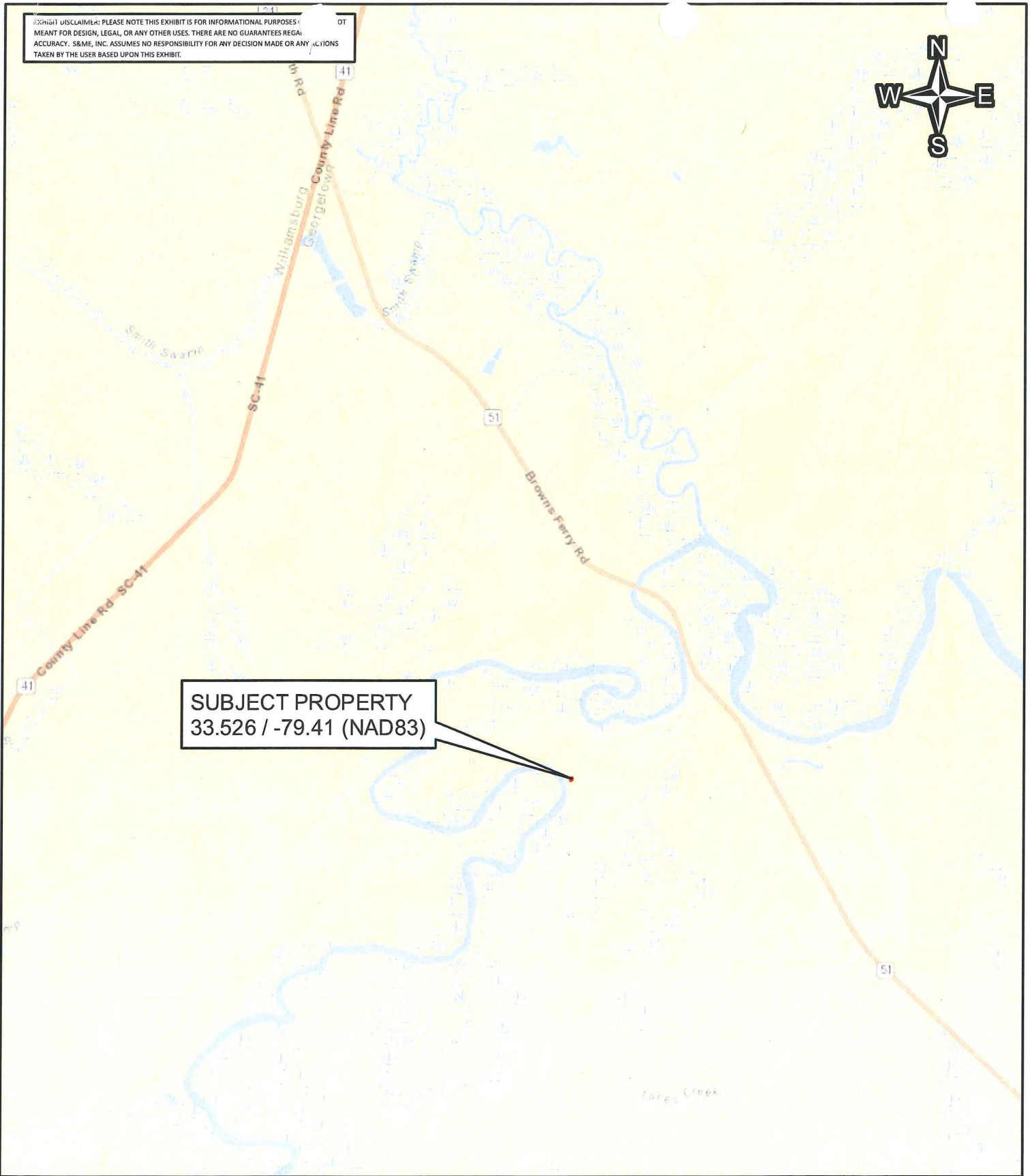

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 0.18 tract (a portion of Lot 30-B labled "Dry Land" on the above refrenced Plat and located on Francis Marion Drive) that is determined to consit entirely of uplands. A site visit conducted on November 24, 2015 revealed that the project boundariy followed a steep topographic break in the landscape. Wetlands located in a low lying area just off site were inundated and contained an abundance of hydrophitic vegetation. Soils on the upland side of the line were saturated however, they had high chroma and value and did not fit any hydric soil indicators. Vegetation and elevation differences were obvious between the off-site wetland and the upland project area. Georgetown County was approximately 20" above average rainfall during the time of the site visit. Georgetown County received 22" of rainfall in October alone. Due to the large amount of rainfall over a short period of time hydrology was greatly exaggerated during the site visit. .

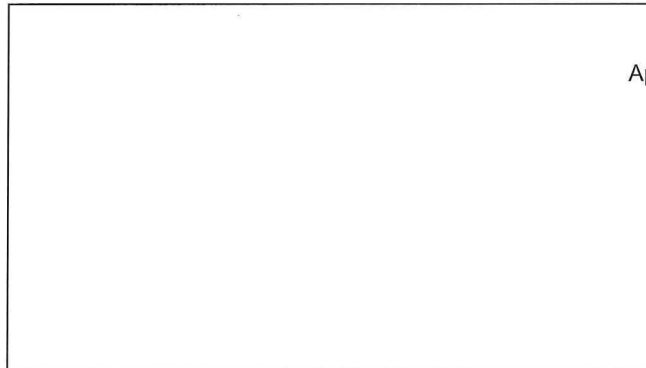
