### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

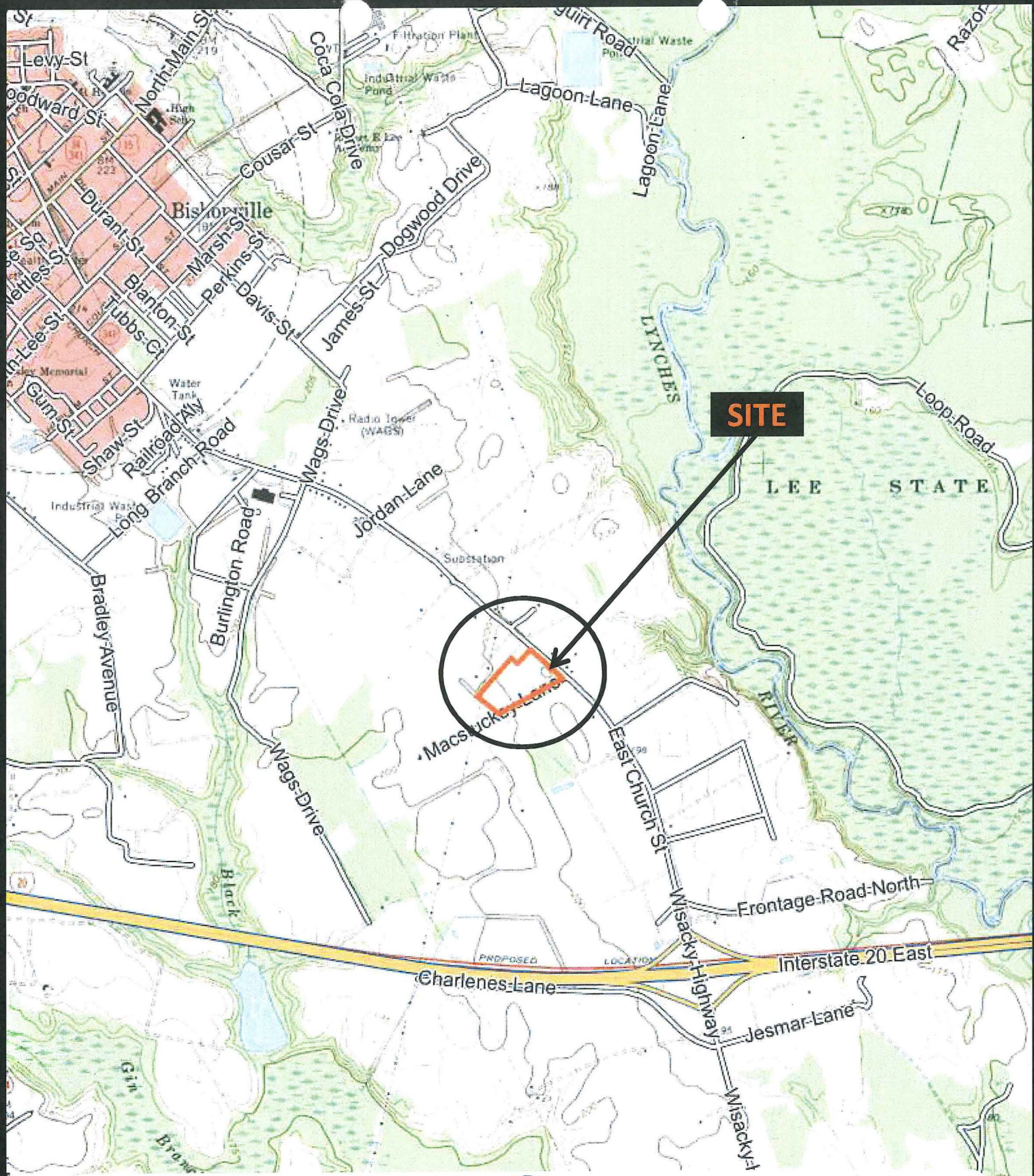

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 15.4 acre tract that was determined to consist entirely of uplands. The USGS topographic survey information located within Bishopville East quad depicts the project area as cleared uplands that do not contain any blue line features or other symbols that would typically represent a water of the United States. The NWIs depict the project area as being comprised entirely of upland agricultural fields. Data sheets provided by the agent revealed that the site does not meet the parameters set forth in the 1987 delineation manual and 2010 coastal plain regional supplement and therefore is not a wetland. Data sheet provided by the consultant revealed that the soils on-site do not meet a hydric soil indicator. Aerial photographs depict the project area as upland agricultural fields. There is a shaded linear feature that bisects the project area, review of photos submitted by the agent reveals that this feature is a linear conveyance over grown with vegetation and that does not contain an OHWM. There are no areas visible in aerial photos that appear to be saturated or inundated or otherwise indicate a WOUS. One linear conveyance is located on-site running southeast to northwest. This feature is not depicted as a blue line on USGS quad maps. Site photos submitted by the agent reveal that the feature is over grown with vegetation and does not contain an OHWM. For the reasons listed above this feature was determined to be a non-jurisdictional feature and the project area was determined to consist entirely of uplands.

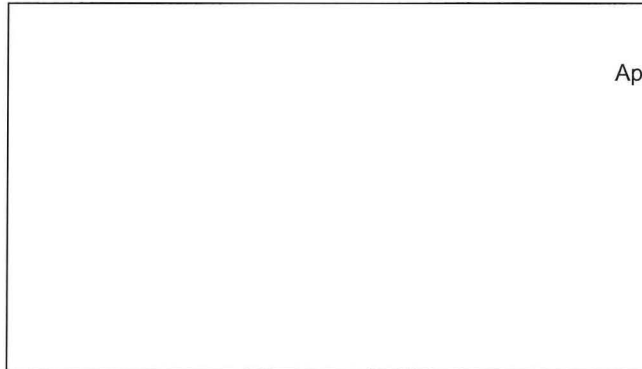
