- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:
There are three non-jurisdictional ponds/features on the project site and shown on a supplemental drawing. These ponds/features were determined to be excavated from uplands as a borrow pits for sand and fill for road construction. As stated in the Preamble to the November 13, 1986, Regulation found on page 41217 (Federal Register Vol. 51 No. 219) “waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States” are generally not considered waters of the U. S. These ponds receive stormwater from the surrounding uplands and are open water ponds. For these reasons, these ponds were determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.

There is one linear feature in the review area located on the eastern property boundary and shown on a supplemental drawing. This feature is approximately 1585 linear feet long, 8 feet deep and 30 feet wide at the top. This feature, which was previously determined to non-jurisdictional, is excavated from uplands and drains uplands and the overflow from one of the non-jurisdictional ponds onsite. This feature was determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
