connections to other waters onsite. This wetland (Non-Jurisdictional Wetlands 3 on the depiction titled "Approximate Wetland/WoUS Map") is immediately surrounded by upland areas. This wetland receives runoff from the surrounding upland areas, but its only outlet is through evapotranspiration. In addition, this wetland would not be considered adjacent to any of the surrounding tributaries, as there is a significant sand ridge (upland) between the wetland and the tributary. Also, due to the sandy subsurface sediment in the wetland, as well as the surrounding uplands, it is unlikely that subsurface flow to the tributary occurs, as might be expected in a more clayey soil subsurface. Runoff and other water that ultimately enters the wetland exists through the processes listed above, or travels directly into the groundwater. The wetland does not have either a surface or apparent subsurface hydrological connection and no apparent ecological interconnectivity with other water features, including any waters of the US and no apparent connection to interstate or foreign commerce. Therefore, the wetland was determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: The reference site contains 5 jurisdictional wetlands that all abut perennial tributaries onsite. The site also contains 4 individually identified tributaries, all of which exhibit perennial flow. These aquatic resources are subject to regulation under Section 404 of the CWA.
