C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 143.86 acre tract that was determined to contain 4.56 acres of jurisdictional freshwater wetlands and 2,178.85 linear feet of jurisdictional tributaries with perennial flow. Wetlands onsite directly abut a tributary that drains unobstructed into the Pocatigo River which drains into the Black River, a TNW. The tributaries are depicted in USGS topographic maps as a solid blue line feature located within a low lying drainage area. The features have a firm sandy bottom and the presence of iron oxidizing bacteria within the tributaries indicates that they are recharged by groundwater. A continuous OHWM and flow were observed onsite during site visits conducted on December 1, 2015 and January 24, 2018. Eight non-jurisdictional man-made agricultural drainage ditches are located onsite. These features were determined to have been excavated out of uplands and to drain only uplands. .
