was assessed for potential jurisdictional flow and adjacent wetlands, of which none were found. The ditching did not have any flow nor pooling of water within it, and did not appear to have more than occasional flow within it for numerous years as the soil profile on the direct banks was a upland sandy soil with greater than 30% uncoated sand grains, very little organic material outside of a thin 2 inch A horizon with a color of 10YR 4/1, and a relatively pale color of 10YR 6/1 at 2-12 inches depth; compared to the wetlands on-site that had a profile of 10YR 3/2 (0-10 inches) and 10YR 5/1 (10-20 inches). While on site Corps personnel assessed the entire length of this ditching system and found no hydric soil or hydrology indicators to indicate that it had more than occasional temporary ponding from rainfall.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This 19.5 acre site located in Sumter, Sumter Co, SC, was previously used for agriculture (farming). 19.11 acres of the site are uplands with both non-forested farm fields and forested uplands, the remaining 0.39 acres consist of palustrine wetlands along the far northern border of the project site.

Sumter West Quadrangle USGS topographic maps depict the 19.5 acre site as 18.37 acres non-forested and 1.13 acres as forested land in the northern border of the site. No aquatic resources or wetlands are depicted on the site.

Sumter soil survey depicts three soils within the project site, including: Wagram-Norfolk-Lucknow complex (0-4% slopes), Goldsboro loamy sand, and Lynchburg-Rains complex (0-2% slopes). Of these soils the Wagram-Norfolk-Lucknow complex is listed as a hydric soil for Sumter County on the 2016 South Carolina Hydric Soil List.

The on-site wetlands are part of a larger off-site wetland system that is north of the project site. This wetland continues off-site, directly abuts the Green Swamp Creek (PRPW), which flows into the Pocotaligo River (PRPW), and then drains into the Black River (TNW) after ~35.5 river miles. The Green Swamp Creek and its adjacent wetlands are shown as solid blue line features with wetland symbols on Sumter West Quadrangle USGS topographic maps, and are visible on aerial imagery from 1994-2017, additionally in areas that the creek system is visible on imagery sinuosity from persistent flow can be identified, all of which leads to the conclusion that the flow pattern for Green Swamp Creek is perennial.

The detailed hydrological flow pattern from the project site to the TNW is: the jurisdictional wetlands continues off-site west-southwest for 0.70 mile where it meets the Green Swamp Creek (PRPW) and its adjacent wetlands. Green Swamp Creek continues a southward progression for 2.25 miles where it drains into Second Millpond, an impoundment of jurisdictional waters. The hydrologic flow then continues to flow south-southeastward for 3.4 miles where it meets the confluence of the Green Swamp Creek (PRPW), the Cane Savannah Creek (PRPW), and the Pocotaligo River (PRPW), from this confluence point the hydrologic flow continues southeast-east within the Pocotaligo River, a braided river system, for 27.8 miles where it drains into the headwaters of the Black River (TNW).

On-site is a ~335 ft. ditching system located on the east-southeast side of the site. During the site visit this ditch was assessed for potential jurisdictional flow and adjacent wetlands, of which none were found. The ditching did not have any flow nor pooling of water within it, and did not appear to have more than occasional flow within it for numerous years as the soil profile on the direct banks was a upland sandy soil with greater than 30% uncoated sand grains, very little organic material outside of a thin 2 inch A horizon with a color of 10YR 4/1, and a relatively pale color of 10YR 6/1 at 2-12 inches depth; compared to the wetlands on-site that had a profile of 10YR 3/2 (0-10 inches) and 10YR 5/1 (10-20 inches). While on site Corps personnel assessed the entire length of this ditching system and found no hydric soil or hydrology indicators to indicate that it had more than occasional temporary ponding from rainfall.
