C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: **The unnamed perennial tributary to Long Branch is located offsite. This perennial stream is**

shown as a blue line on the USGS topo map and a perennial tributary on the USDA-NRCS soils map. Water is observed flowing in the tributary at the dates of the aerial imagery photos and could be seen from the old dam. At the time of the site visit the dam had been breached and braided stream channels with surface film and flocculent from iron oxidizing bacteria and filamentous algae, had developed in the wetland and water was flowing directly into the offsite perennial tributary. The offsite tributary was observed from the dam to have well differentiated bed and bank features, a clear natural line impressed in the bank, leaf litter disturbed or washed away, strong sediment deposition, abrupt change in plant community, and well defined benches. Available data led this office to conclude the tributary has a perennial flow regime.

Water was observed flowing from the toe of the upland slopes, in some places over exposed bedrock, and into the wetland. Surface film and flocculent from iron oxidizing bacteria was present in this flow. Braided stream channels have developed in the wetland which have a surface film and flocculent from iron oxidizing bacteria, in addition to filamentous algae, indicative of slow and steady flow. There is a continuous surface connection between the wetland upstream of the breached dam and the offsite perennial tributary. Water flow is direct and unimpeded from the wetland into the offsite perennial tributary.**

Historically, an impoundment was documented on USGS topo map blue line stream (perennial), USDA-NRCS soils map perennial tributary, and historic aerials up through 2017, and was breached, which led to the development of abutting wetlands with braided stream channels within the footprint of the impoundment.
