C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was performed for this Jurisdictional Determination request. After reviewing the consultant's delineation submittal and all of the best available information (i.e. aerial photography, topographic maps, soil survey information, and LiDAR maps), the Corps has determined that the subject property consists entirely of uplands. A data point was taken in the lower gradient areas of the field where it is mapped as a Rains (hydric) soil and was determined to be non-hydric. The soil in these areas had a Chroma of 3 and Value of 3 from 0"-25" from the soil surface which does not fit any hydric soil indicator. A ditch approximately 1,292 linear feet and 6 foot wide exists on the northeastern portion of the project boundary. After reviewing aerial photography, topographic maps, and LiDAR information, it was determined that the ditch was excavated entirely out of uplands and drains only uplands and is non-jurisdictional. The ditch was previously observed on the adjacent site to the northwest (SAC# 2015-00248) and was also determined to be non-jurisdictional. Field observations included leaf litter and debris in the ditch and overgrown with vegetation.
